NEW LEGAL DOCUMENT

DIRECT MONEY SUPPORT FOR PEOPLE WITH MERITORIOUS SERVICES TO THE REVOLUTION.

On July 21, 2022, the Ministry of Finance issued **Circular 44/2022/TT-BTC**, which regulates the management and use of regular payments for preferential regimes. Subjects include people with meritorious services to the revolution; relatives of people with meritorious services to the revolution and resistance participants.

According to Article 5 of Circular 44, the amounts for the above subjects and beneficiaries of the preferential regime include:

- Nursing and health rehabilitation expenses at home;
- Expenses to support the purchase of orthopedic devices, assistive devices, means and necessary rehabilitation equipment;
- Educational incentive subsidies;
- Expenses for visiting martyrs' graves; supporting the movement of martyrs' remains;
- Expenses for one-time allowance when posthumously conferring the "Fatherland attribution" certificate to the martyr's relatives/heirs;
- Funeral allowances, allowances for martyrs' worship;
- Extra money for meals on holidays and New Year's holidays with wounded soldiers, sick soldiers, policy beneficiaries such as class B war invalids and war invalids with body injuries of 81% or more who are enjoying monthly preferential allowances;
- Money to buy People's Newspaper for revolutionary activists before January 1, 1945 and revolutionary activists from January 1, 1945 to before the general uprising of August 19, 1945;
- Spending on gifts from the President.

This Circular takes effect from September 5, 2022

LIST OF AQUATIC ANIMALS AND ANIMAL PRODUCTS THAT WILL BE EXEMPT FROM QUARANTINE

This is the content of **Circular 06/2022/TT-BNNPTNT** regulating the quarantine of aquatic animals and animal products, which was issued on July 28, 2022.

Accordingly, the list of aquatic animals and animal products that will be exempt from quarantine include:

- (1) Imported aquatic animals and animal products in the diplomatic category.
- (2) Aquatic animal products imported as raw materials for export processing or export production. (new regulations compared to Circular 26/2016/TT-BNNPTNT)
- (3) Aquatic animal products as test samples. (new rules)
- (4) Imported aquatic animal products for display at fairs and exhibitions. (new rules)
- (5) Aquatic animal products used as food for export are recalled or returned. (new rules)

In addition, processed aquatic animal products used as imported food, which are carried on people for personal consumption (not exceeding 05 kg), are no longer on the list of aquatic animals and animal products. quarantine exemption.

Circular 06/2022/TT-BNNPTNT takes effect from September 11, 2022.



EXPENSES TO SUPPORT THE EATING AND DRINKING OF ATHLETES AND COACHES IN THE MILITARY


On July 18, 2022, the Ministry of National Defense issued Circular 53/2022/TT-BQP amending and supplementing Clause 8 Article 4 and replacing Appendix I of Circular 164/2019/TT-BQP. The Circular stipulates the food and tonic fees of coaches, athletes and physical education teachers in the Army.

Accordingly, the daily allowance for meals and tonics of coaches, athletes and gymnastics teachers in the Army has been increased.

The recipients of money are divided into 5 levels, including the following subjects: Coach, Athlete, Athlete, and Trainer. Depending on the level of the subject, the allowance will vary, specifically from 87,000 VND to 129,000 VND per person per day.

Regarding the duration of the subsidy and the amount of the subsidy. The list is subsidized according to the approval and decision of the Chief of General Staff. Non-permanent athletes who are established by the Chief of the General Staff will provide a maximum allowance of 60 days. Amateur athletes are subsidized for each day of practice.

The Circular takes effect from September 2, 2022.



HO CHI MINH CITY TRIES EMERGENCY DEPRESSION

When detecting anyone such as family members or colleagues,... if there are manifestations and signs of major depression, immediately call 115 - the emergency line number of the Emergency Center **115** or the number **19001267** - the customer care phone number of the Ho Chi Minh City Mental Hospital.

After receiving the call, the medical workers on call center will ask some screening questions and report the emergency news to the 115 emergency team.

Receiving the news, the 115 emergency team will approach the scene to persuade and take the patient to a psychiatric hospital for care and treatment, when the mental disorder condition is in remission, the patient will be transferred to the locality for outpatient care through a community-based mental disorder care network.
