NEW LEGAL DOCUMENT

THE GOVERNMENT REQUESTS THE IMMEDIATE ABOLITION OF THE REGULATIONS ON THE PRESENTATION OF HOUSEHOLD REGISTRATION BOOKS

On September 11, 2022, the Government issued Resolution No. 121/NQ-CP at the regular Government meeting in August 2022.

- Ministers and heads of ministerial-level agencies review documents under their management, identify problems that need to be amended and propose amendments and roadmaps to meet the roadmap set out in Project 06. , Law on Residence and removal of household registration books and temporary residence books, send the results to the Ministry of Public Security before September 20, 2022.
- Provincial-level People's Committees shall review, adjust and annul regulations requiring the presentation of household registration books to use identity cards, electronic identification, and population data when performing transactions and administrative procedures. main for citizens.

Ensuring information security conditions for connection and use of data in the National Population Database instead of the requirement to present a household registration book. Completed in October 2022.

NEW LEGAL DOCUMENT

PROMULGATING NEW REGULATIONS ON DISCIPLINARY ACTION IN TRADE UNIONS

On August 12, 2022, the General Confederation of Labor issued Decision 5130/QĐ-TLĐ promulgating the Regulation on disciplinary action in trade union organizations.

- For the collective executive committee, standing committee, trade union inspection committee and organizations in the trade union system: reprimand, warn, dissolve.
- For individuals who are trade union members: Reprimand, warning, expulsion.
- For individuals who are trade union officials: reprimand, warning, dismissal (from trade union positions), expulsion.


Cases that have not yet been considered for disciplining officials and union members who violate discipline include:

- Being pregnant, on maternity leave or nursing a baby under 12 months old.
- Suffering from a serious illness or temporarily losing cognitive capacity, suffering from a serious illness requiring inpatient treatment at a hospital and certified by a competent health authority (at the district level or higher).
- Being held in custody or temporary detention awaiting the conclusion of an investigation, prosecution or trial for illegal acts.

6 DRAFT LAWS WERE SUBMITTED TO THE NATIONAL ASSEMBLY FOR CONSIDERATION AND APPROVAL AT THE 4TH SESSION

On September 11, 2022, the Prime Minister issued Official Letter 805/CD-TTg on strengthening the law-making work and completing law projects at the 4th Session of the XV National Assembly.

In order to continue strengthening the law-making work in the coming time, the Prime Minister requested the ministers, heads of ministerial-level agencies, chairmen of the People's Committees of the provinces and cities to implement the following tasks:

- To require the development of law projects in accordance with the guidelines of the Party and the National Assembly; strictly implement the Law and Ordinance Development Program of the National Assembly, the National Assembly Standing Committee...
 - The agencies in charge of drafting projects and drafting legal documents closely coordinate with agencies of the Party, the National Assembly and related agencies, widely consulted with associations, businesses, experts, subjects affected by the policy...

PILOT ONLINE COURT FEE PAYMENT FROM OCTOBER 1, 2022

On September 15, 2022, the Supreme People's Court issued Decision No. 273/QĐ-TANDTC on pilot implementation of online public justice service collection and payment of court fee and court fee advances on the Portal. National public service.

Accordingly, the Supreme People's Court decided to pilot the online public judicial service collection and payment of court fee advances and court fees on the National Public Service Portal from October 1, 2022 until the end of the year. October 31, 2022 at the Courts with the following names:

- People's Court of Long Bien District, Hanoi City;
- People's Court of Dong Da District, Hanoi City;
- People's Court of Hoan Kiem District, Hanoi City;
- People's Court of Gia Lam District, Hanoi City;
- People's Court of Hai Ba Trung District, Hanoi City.
