NEW LEGAL DOCUMENT

INFORMATION SHARED FOR THE NATIONAL POPULATION DATABASE SYSTEM




Circular 46/2022/TT-BCA stipulating the connection, sharing and exploitation of information between the National Database on Population population with national databases, specialized databases and other information systems promulgated by the Minister of Public Security on November 4, 2022.




Accordingly, the information to be shared for the national population database system is regulated as follows:

- The shared electronic civil status database, the residence database, the resident database Citizen identification, health databases and other specialized databases share information about citizens for the national population database system in accordance with the law to ensure consistency, complete, accurate and timely.



- The specialized information associated with citizens (specified in Appendix I issued together with this Circular) when shared by agencies and organizations with the Ministry of Public Security,

the agency managing the national database shall: The Ministry of Public Security is the focal point for receiving, exploiting and using in service of population management and meeting other professional work requirements of the police of units and localities according to their functions and duties. assigned duties and powers.



Circular 46/2022/TT-BCA takes effect from December 19, 2022.


CONDITIONS WITH SPECIAL BONDS AS THE BASIS FOR REFINANCING

The Governor of the State Bank of Vietnam issued Circular 15/2022/TT-NHNN dated 30/11/2022 providing for refinancing on the basis of special bonds of the Asset Management Company of Vietnam Credit Institutions. .

Accordingly, special bonds used as a basis for refinancing or extending refinancing must fully satisfy the following conditions:

- Special bonds are legally owned by credit institutions and are being deposited at State Bank Transaction Office.
- Not a special bond in progress.
- Not in the list of special bonds that the credit institution is requesting the State Bank to consider extending the term according to the State Bank's regulations on the purchase, sale and handling of bad debts of the Management Company. assets of Vietnamese credit institutions (hereinafter referred to as Asset Management Company).
- On the date the credit institution makes the list of special bonds as a basis for refinancing and extending the refinancing and the date the credit institution updates the list of special bonds as prescribed in Clause 5, Article 10 of this Circular. 15/2022/TT-NHNN, the remaining term of the special bond is longer than the time limit for refinancing or extending the refinancing for at least 6 months.

Circular 15/2022/TT-NHNN takes effect on January 17, 2023 and replaces Circular 18/2015/TT-NHNN dated October 22, 2015.

ESTABLISHMENT OF INTERDISCIPLINARY INSPECTION TEAMS ON FOOD SAFETY DURING TET 2023

The Central Inter-sectoral Steering Committee for Food Safety has a Plan 1637/KH-BCĐTUAATP dated December 5, 2022 on the implementation of food safety assurance during the Lunar New Year and the Spring Festival 2023.

Accordingly, the overall objective of the Plan is to ensure food safety in the production, processing, trading, importation and use of food;

Strengthen control and timely prevent the production and trading of fake and poor quality food;


Ensuring the interests of consumers; prevention of food poisoning during the Lunar New Year and Spring Festival 2023.

Regarding food safety inspection activities:

- At the Central level: The Central Inter-sectoral Steering Committee for Food Safety established 06 delegations. Specialized inspection, conducting inspection in 12 provinces and cities.

- In the locality: Establish interdisciplinary inspection and examination teams at all levels, from the provincial to the commune level.

The time to implement food safety assurance during the Lunar New Year and Spring Festival 2023 is from December 15, 2022 to the end of March 12, 2023 and will be implemented nationwide. .

RENAMED THU THIEM 2 BRIDGE TO BA SON BRIDGE

At the 8th Session, the Ho Chi Minh City People's Council X adopted a resolution to name 2 bridges over the Saigon River.

Accordingly, Thu Thiem 1 bridge connecting Ngo Tat To street, Nguyen Huu Canh street (Binh Thanh district) to Nguyen Co Thach street, Thu Thiem new urban area (Thu Duc city) will be named Thu Thiem. The bridge is 1.2 km long, total investment of about VND 1,450 billion was inaugurated in 2008.

Thu Thiem 2 bridge connecting Ton Duc Thang Street (District 1) to Thu Thiem New Urban Area (Thu Duc City) will be named Ba Son. The bridge is nearly 1.5 km long with a total investment of 3,100 billion VND - the largest budget of bridges in Ho Chi Minh City so far.
