# NEW LEGAL DOCUMENT



## LIST OF VIETNAM'S EXPORTS AND IMPORTS FROM DECEMBER 1, 2022

The Minister of Finance promulgates Circular 31/2022/TT-BTC on the List of exported and imported goods (exports and imports) Vietnam takes effect from December 1, 2022 and replaces Circular 65/2017/TT-BTC dated June 27, 2017, Circular 09/2019/TT-BTC dated February 15, 2019.



Accordingly, promulgated together with Circular 31/2022/TT-BTC includes 02 appendices:

- Appendix I: List of Vietnam's import and export goods;
- Appendix II: 06 general rules explaining the classification of goods according to the List of Import and Export Goods of Vietnam based on the Harmonized System of Commodity Description and Coding of the World Customs Organization.

The list of Vietnam's export and import goods is used to:

- Formulate the Tariffs applicable to export and import goods;
  - Develop lists of goods for state management in accordance with the Government's regulations and the provisions of Clause 4, Article 26 of the Customs Law ;
  - State statistics on export and import goods;
  - Serving the state management of export and import of goods and other fields.

# NEW LEGAL DOCUMENT

## PILOT AUCTION OF LICENSE PLATES FOR CARS FOR 3 YEARS

This content is stipulated in Resolution 73/2022/QH15 on piloting the auction of license plates of automobiles approved by the National Assembly on November 15, 2022.

Accordingly, the starting price, advance deposit, price step, and proceeds from the auto license plate auction are regulated as follows:

- The starting price of a car license plate put up for auction is 40,000,000 copper.
- The deposit is equal to the starting price of a car license plate put up for auction.
- The price step is 5,000,000 VND.
- The proceeds from the auto license plate auction, after deducting the expenses for organizing the auction, shall be remitted to the central budget in accordance with the law on state budget.

In addition, the license plate of the car put up for auction is the number plate of the car with a white background, black letters and numbers, except for the license plates issued for:

- + Automobiles of military enterprises doing business.
- + Cars of projects, economic organizations in joint ventures with foreign countries.
- + Cars of foreign organizations and enterprises, diplomatic missions, consular missions, representative offices of international organizations and foreigners working in foreign agencies and organizations and international operations in the territory of Vietnam.

Resolution 73/2022/QH15 takes effect from July 1, 2023 and will be implemented for 3 years.

## 04 CASES OF REGISTRATION OF SECURITY INTEREST

On November 30, 2022, the Government issued Decree 99/2022/ND-CP on registration of security interests.

- Registration of mortgage of property, pledge of property, retention of ownership in accordance with the provisions of the Civil Code and other relevant laws;

- Registration according to the agreement between the securing party and the secured party or at the request of the secured party, except for property holding;

- Register for notice of disposal of security property in case an asset is used to secure the performance of many obligations but many parties jointly receive the security or in case the securing party and the secured party have an agreement. ;

- Register to change the registered content; deregistration of registered contents for the above 03 cases..

(Currently, cases where security interest must be registered include: mortgage of land use rights; mortgage of land-attached assets if certificate of ownership on the certificate of land use rights...; Pledge of aircraft, mortgage of aircraft; Mortgage of ships.)

Decree 99/2022/ND-CP takes effect from January 15, 2023 and replace Decree 102/2017/ND-CP.

Ho Chi Minh City Department of Labor and Social Affairs recently sent a letter requesting businesses operating in the area to report on the labor situation, salary in 2022 and Tet bonus plan in 2023.

Accordingly, enterprises need to ensure full payment, on time as planned; do not let salary and bonus debts occur.
